

#### RE: CLAIM FOR PATENT RIGHTS

We hereby claim for PATENT RIGHTS for the manufacture of the FIRST Organic Bio-Chemical Compounds.

This is medicine that does not contain any chemical residue.

Manufacturing is based on the Kinetic Theory of matter.

- 1. The ability to extract chemicals and food nutrients without changing their micro-biological status.
- 2. Manufacturing medicine that does not have any chemical residue.

### Manufacturing:

We break down the ingredients to the atom level using Ammonia gas and Fresh water, purify using sodium bi-carbonate, re-combine at -25°c using calcium oxide and zinc ions under air -tight conditions. We then ferment using yeast extract and sugar for a specific period of time.

The result is a NATURAL compound.

We extract the following chemicals and food nutrients:-

- 1. Yeast extract
- 2. Phosphorous.
- 3. Ammonia.
- 4. Sulphur.
- 5. Sodium bi-carbonate.
- 6. Zinc ions.
- 7. Citric acid.
- 8. Ascorbic acid
- 9. Amino acids
- 10. Vitamins A, B, C and D.
- 11. Iodine
- 12. Cinamone ions
